The Effects of Deviance on Society . As we have noted, deviance is generally perceived to be disruptive in society. It can weaken established social norms, and create division and disorder. But it also has other functions which are not necessarily harmful and may actually be beneficial to society. It is one way that social change occurs. If a deviant act becomes more accepted it soon may be considered legitimate.

Travis Hirschi noted that these inner and outer restraints form a person's self-control, which prevents acting against social norms. The key to developing self-control is proper socialization, especially early in childhood. Children who lack this self-control, then, may grow up to commit crimes and other deviant behaviors.
