The purpose of this affidavit is for designers/contractors to obtain a “no-plan permit” for fire alarm systems when the scope of work is limited to the addition or alteration of 0 - 14 fire alarm devices and/or appliances in buildings with existing fire alarm

## **Affidavit for Fire Alarm FORM DS Alterations or Tenant 163 ...**

This includes stand-alone sprinkler system projects where none of the piping exceeds 2 ½" as well as stand-alone power-limited fire alarm projects (replacement, upgrades, etc.) but does not allow a contractor to design (stamp) fire sprinkler or fire alarm work that is a part of a project prepared by an architect or engineer.
